ELECTRICITY:

The Sandwich Fair Association Inc. will provide the electrical needs for each concession, stock truck, or trailer unit. Power furnished will be 120/208 volt single phase or 3 phase unless otherwise noted. Vendors must contact the Round Office regarding alternate voltage, the amount of electricity needed, and the location of the connection(s). A work order will be issued to the electricians when the fees are paid in full at the Round Office. Vendors will receive a copy of the work order when services are completed. After the closing of the fair, electrical service will be disconnected on the following Tuesday at 5:00 p.m. Campgrounds will remain in operation. **You will be required to pay a \$175 surcharge per** hookup before the electricians on sight can provide you with additional electrical power, i.e. direct connection. All electrical fees must be paid in full at the Round Office.
